Horse Administration Fee Standard	R 270.00	R 243.00	All horses, including non-graded rider horses must be registered with DSA. This annual fee will ensure that all performance history is kept. No additional horse registration fee will be applicable as the annual admin fee will cover registration. If a non graded rider upgrades their membership then the accumulated points are activated.
Horse Administration Fee if Microchip is valid	R 202.50	R 182.25	This is a reduced Horse Administration fee and is applicable only to horses, including non-graded rider horses which have a valid and proven microchip. No additional horse registration fee will be applicable as the annual admin fee will cover registration. If a non graded rider upgrades their membership then the accumulated points are activated.
Show Holding Body	R 550.00	R 495.00	All registered Show Holding Bodies need to pay this annual fee regardless if they are also a registered club.
Temporary Licence Fee per licence (only 2 licences are allowed per year)	R 160.00	R 144.00	This applies to Non-DSA and Non-SAEF registered riders who want to compete occasionally. Two Show Entry Licences are available to non-registered members to compete between 1 Jan 2020 and 15 December 2020. The rate quoted is the rate per licence.  <u>Conversion from Temporary licence to Full Membership:</u> Current DSA 2020 Membership Fees less R 20 .00 plus Current SAEF Membership fee less R 150 per licence that has been taken up during the year. This fee is due directly to SAEF upon conversion.
